The Boat Owner agrees to the Terms and Conditions of this document, Essex Marina Rules and Regulations and Essex Marina Terms and Conditions, which are attached and incorporated herein by reference. It is understood that this contract may not be altered or amended unless a written instrument is signed by an owner of Essex Marina and the Boat Owner.

All Charges unpaid after 30 days are subject to a service charge of 1.5% per month. All outstanding balances must be paid before removing any vessel from Essex Marina's facility (hereinafter "Marina"), otherwise a lien will be placed upon the vessel. Delinquent accounts processed for collection shall be subject to all cost of collection and attorney's fees. This contract is for the above period only. The Boat Owner agrees to daily transient storage fees if the boat is left on the Marina premises beyond the expiration date of this contract, and contract terms continue until the boat is removed.

The Boat Owner understands that the water slip fee is significantly smaller than the value of his or her vessel. As a result, the Boat Owner and Marina agree that the boat is stored at the marina at the sole risk of the Boat Owner and that the Marina will not be liable for any loss of or damage to the Boat under any circumstances, including fire, theft, vandalism, water damage, and any negligent acts or omissions. The Boat Owner also agrees to release, indemnify and hold harmless the Marina from any liability for any personal injury or property loss of the Boat Owner, his employees, servants, agents and guests under any circumstances, including any negligent acts or omissions of the Marina, to the extent permitted by law. The below signed person personally covenants and agrees to defend, indemnify and save the Marina harmless from any claims, demands, defenses, losses, causes of action, third party claims and causes of action, suits judgments and any executions thereon arising from Marina's reliance of said signature.

The person who has signed below as the Boat Owner hereby warrants and represents that he/she is in fact the true Boat Owner of the Vessel, and that he/she has full power and right to enter into this agreement for himself/herself and for the Vessel. Further, the Boat Owner's signature was properly placed upon this agreement, and there are no restrictions of any kind upon the Boat Owner or the Vessel which limit or restrict his signature from binding the Boat Owner and the Vessel to each and every term and condition of this contract. If the Boat Owner is a Corporation, the individual signing this contract on behalf of the corporation personally guarantees payment on behalf of the corporation.
